Traveller's Quick Guide



PROTOCOLS FOR ALL TRAVELLERS

All travellers to Bermuda aged 10 and up are required to take a COVID-19 test <u>1-3 days</u> before departure and are required to submit an online Traveller Authorisation form in addition to their negative pre-arrival results. Submission of a Travel Authorisation application within 24 hours of your travel date will <u>not</u> be approved.

All travellers are required to take a COVID-19 test upon arrival and test on days 4, 8 and 14 of their trip. Day 0 is classified as the date you land on-island. A return home test is also arranged for visitors. All tests are covered in the Traveller Authorisation fee, auto scheduled for your convenience, and confirmed by email.

Children aged 17 and under are <u>not</u> required to be vaccinated and are <u>not</u> subject to quarantine, if the adults in their party are fully vaccinated.

Note: No flight originating in Brazil, India or South Africa will land in Bermuda and any arriving passenger who has travelled to those countries within the previous 14 days will be mandatorily quarantined for 14 days.

PROTOCOLS FROM MAY 5 - JUNE 5, 2021

Immunised travellers

- Must have received the required dose(s) of their vaccine plus two weeks since last dose
- After arrival test, residents can sanctuary at home and visitors are invited to enjoy amenities at their accommodation property while awaiting lab result*
- After negative landed result, no restrictions on movement**
- · Must adhere to COVID-19 public health guidelines
- *Contact property for details on permitted amenities available for your use
- **Arrivals by midday typically have results in time for dinner; up to 24 hours in rare cases

Non-immunised travellers

- Are required to wear a wristband
- Must quarantine at home or at their accomodation property until their negative day 4 test result is received*
- Restricted activities relaxed after negative day 4 test
- Must adhere to COVID-19 public health guidelines
- *Contact property for details on permitted amenities available for your use

PROTOCOLS FROM JUNE 6, 2021

Immunised travellers

- Must have received the required dose(s) of their vaccine plus two weeks since last dose
- After arrival test, residents can sanctuary at home and visitors are invited to enjoy amenities at their accommodation property while awaiting lab result*
- \bullet After negative landed result, no restrictions on movement**
- Must adhere to COVID-19 public health guidelines
- *Contact property for details on permitted amenities available for your use
- **Arrivals by midday typically have results in time for dinner; up to 24 hours in rare cases

Non-immunised travellers

- Are required to wear a wristband
- Must be subject to supervised quarantine for 14 days at their own expense. Payment is due prior to arrival for visitors and prior to departure from Bermuda for residents*
- Must adhere to COVID-19 public health guidelines
- *Does not apply to children ages 17 and below, if the adults in the party are fully vaccinated.
